PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **67521** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Milford B. Bates and Mary K. Bates of S. Myrtle Route, Box 226-1, Myrtle Creek, Oregon 97457**, for the use of the waters of an unnamed stream and reservoir to be constructed under Application R-67520, Permit R-9387, for the PURPOSE of irrigation and stock water; being 0.175 cubic foot per second for irrigation of 15.0 acres and 0.005 cfs for stock water

that the PRIORITY OF THE RIGHT dates from **October 12, 1983** for 0.10 cfs and **January 3, 1984** for 0.08 cfs

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.18 cfs**

The POINT OF DIVERSION is to be LOCATED: **1030 feet South and 520 feet East from the Northwest Corner of Section 22, being within NW 1/4 NW 1/4, Section 22, Township 29 South, Range 4 West, WM, in the County of Douglas.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

**Township 29 South, Range 4 West, WM Section 21 SE 1/4 NE 1/4 4.0 acres
Section 22 SW 1/4 NW 1/4 11.0 acres**

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre from direct flow and storage from reservoir to be constructed under Permit R-9387, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **March 2, 1985** , and shall thereafter be prosecuted with reasonable diligence and be completed on or before **October 1, 1985** .

Complete application of the water to the proposed use shall be made on or before **October 1, 1986** .
