### PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **67982** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Miller Forests, Partnership, of PO Box 12395, Salem, Oregon 97309, phone 362-9313,** for the use of the waters of Pettijohn Creek when available with any deficiency in the available supply from Pettijohn Creek to be made up by \* for the PURPOSE of **irrigation of 9.4 acres**

that the PRIORITY OF THE RIGHT dates from **December 9, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.12 cfs**

The POINT OF DIVERSION is to be LOCATED: **Pettijohn Creek - 1650 feet South and 1250 feet West from the Northeast Corner of Section 6, being within SE 1/4 NE 1/4, Section 6, Township 8 South, Range 3 West; Willamette River - 1410 feet North and 780 feet East from the Northwest Corner of Section 31, being within the NW 1/4 SW 1/4 of Section 31, Township 7 South, Range 3 West, WM, in the County of Marion.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

\* **appropriation from Willamette River, provided the total diverted from both sources shall not exceed 0.12 cubic foot per second,**

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **March 2, 1985**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before **October 1, 1985**.

Complete application of the water to the proposed use shall be made on or before **October 1, 1986**.
