PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **56041** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Carl Lovelady of Route 3, Box 537-B, Corvallis, Oregon 97330, phone 753-6930, for the use of the waters of Baker Slough, a channel of the Willamette River,**
for the PURPOSE of **irrigation of 51.3 acres**

that the PRIORITY OF THE RIGHT dates from **November 7, 1977**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.64 cubic foot per second**

The POINT OF DIVERSION is to be LOCATED: **Diversion 1 - 4380 feet North and 1450 feet East from the Southeast Corner of Gage DLC 45, being within the NW 1/4 NW 1/4 of Section 1; Diversion 2 - 500 feet North and 140 feet West from the Northwest Corner of Fogle DLC 46, being within the NW 1/4 NE 1/4 of Section 1, both in Township 13 South, Range 5 West, WM, in the County of Benton.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **March 9, 1985**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **86**.
