PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **65352** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Robert C. Macdonald and Jean S. Macdonald, for the United States, Deschutes National Forest of 410 Jerome Avenue, Astoria, Oregon 97103, phone 325-3827, for the use of the waters of Metolius River, a tributary of Deschutes River, for the PURPOSE of domestic use for one family and irrigation of lawn or noncommercial garden, being 4.80 gallons per minute for domestic use and 0.025 gpm for irrigation

that the PRIORITY OF THE RIGHT dates from July 25, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 5.05 gpm

The POINT OF DIVERSION is to be LOCATED: Diversion 1 - 1100 feet South and 960 feet West; Diversion 2 - 1200 feet South and 1120 feet West; both from the E 1/4 Corner of Section 15, being within the NE 1/4 SE 1/4 of Section 15, Township 13 South, Range 9 East, WM, in the County of Jefferson.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 13 South, Range 9 East, WM Section 15 NE 1/4 SE 1/4 0.30 acre Irrigation and Domestic use
NW 1/4 SE 1/4 0.13 acre Irrigation
Lot 3 Tract C

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before March 9, 1985, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1985.

Complete application of the water to the proposed use shall be made on or before October 1, 1986.
