PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **67359** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **John Hannah of 2171 Jackie Avenue, Roseburg, Oregon 97470, phone 679-4412,** for the use of the waters of South Umpqua River, a tributary of Umpqua River, for the PURPOSE of **irrigation and domestic use for one family, being 0.56 cubic foot per second for irrigation of 45.0 acres and 0.005 cfs for domestic**

that the PRIORITY OF THE RIGHT dates from **October 6, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.565 cubic foot per second**

The POINT OF DIVERSION is to be LOCATED: **1150 feet South and 1500 feet West from the Northeast Corner of the SE 1/4 of Section 15, being within the NW 1/4 SE 1/4 of Section 15, Township 28 South, Range 6 West, WM, in the County of Douglas.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 28 South, Range 6 West, WM Section 15 NE 1/4 SE 1/4 16.6 acres Irrigation
NW 1/4 SE 1/4 28.4 acres Irrigation
SE 1/4 SE 1/4 Domestic

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **March 16, 1985**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85**

Complete application of the water to the proposed use shall be made on or before October 1, 19 **86**
