PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **67916** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Roy Kilpatrick of PO Box 13, Mt. Vernon, Oregon 97865, phone 932-4455, for the use of the waters of Fall Creek, a tributary of Beech Creek, for the PURPOSE of irrigation of 24.0 acres

that the PRIORITY OF THE RIGHT dates from October 14, 1983 for 0.06 cubic foot per second and January 9, 1984 for 0.54 cfs

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.6 cubic foot per second of water

The POINT OF DIVERSION is to be LOCATED: 600 feet South and 1600 feet West from the Northeast Corner of Section 3, being within the NW 1/4 NE 1/4 of Section 3, Township 13 South, Range 30 East, WM, in the County of Grant.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 13 South, Range 30 East, WM Section 11	NW 1/4	NW 1/4	3.0 acres
	SW 1/4	NW 1/4	4.0 acres
	NW 1/4	SW 1/4	2.0 acres
	SE 1/4	NW 1/4	10.0 acres
	NE 1/4	SW 1/4	5.0 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **March 16, 1985** , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85** .

Complete application of the water to the proposed use shall be made on or before October 1, 19 **86** . Extended to October 1987
