PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 67930 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Heinz H. Herrmann of 8827 Hazeltine, Panorama City, California 91402, phone (213)892-4095, for the use of the waters of Applegate River and 4.0 acre-feet stored water from Applegate Lake Reservoir constructed under Permit R-7810,* for the PURPOSE of domestic use for one family, irrigation and supplemental irrigation of 2.0 acres, being 0.005 cubic foot per second for domestic use for one family and 4.0 af stored water from Applegate Lake Reservoir for supplemental irrigation that the PRIORITY OF THE RIGHT dates from October 14, 1983 for 0.03 cfs and January 6, 1984 for 4.0 af

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.03 cfs

The POINT OF DIVERSION is to be LOCATED: 750 feet North and 1225 feet East from the Southwest Corner of the SW 1/4 of Section 5, being within the SW 1/4 SW 1/4 of Section 5, Township 37 South, Range 6 West, WM, in the County of Josephine.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

* tributaries of Rogue River,

Township 37 South, Range 6 West, WM Section 5 SW 1/4 SW 1/4 2.0 acres
SW 1/4 SW 1/4 Domestic use

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and is subject to the terms and conditions of Contract 4-07-10-W0512 between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Director, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before March 16, 1985, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1985.

Complete application of the water to the proposed use shall be made on or before October 1, 1986.
