PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 67707 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Green Mt. Lutheran Summer Camp Inc., c/o Fred Currie, Box 21-B, Myrtle Creek, Oregon 97457, phone 863-5565, for the use of the waters of South Umpqua River, a tributary of Umpqua River, for the PURPOSE of irrigation of 2.0 acres, community building use and domestic use for one family, being 0.013 cfs for irrigation, 0.01 cfs for community building use and 0.005 cfs for domestic use that the PRIORITY OF THE RIGHT dates from October 13, 1983 for 0.02 cfs and February 1, 1984 for 0.008 cfs

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.028 cubic foot per second

The POINT OF DIVERSION is to be LOCATED: 1530 feet North and 1100 feet East from the Southwest Corner of Section 28, being within the NW 1/4 SW 1/4 of Section 28, Township 30 South, Range 3 West, WM, in the County of Douglas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before March 30, 1985 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 85.

Complete application of the water to the proposed use shall be made on or before October 1, 19 86.
