PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68005** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Sandy Farms of 34500 SE Highway 211, Boring, Oregon 97009, phone 668-4525 (office) or 668-6598 (home), for the use of the waters of Sandy Farms 4 Reservoir to be constructed under Application R-68004, Permit R-9689, for the PURPOSE of supplemental irrigation of 176.4**

that the PRIORITY OF THE RIGHT dates from **January 25, 1984**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **4.3 acre-feet stored water only**

The POINT OF DIVERSION is to be LOCATED: **1240 feet South and 950 feet West from the Northeast Corner of Section 27, being within the NE 1/4 NE 1/4 of Section 27, Township 2 South, Range 4 East, WM, in the County of Clackamas.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to a diversion of not to exceed 2.5 from storage from reservoir to be constructed under Permit R-9689, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

Actual construction work shall begin on or before **May 14, 1985**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **86**

Complete application of the water to the proposed use shall be made on or before October 1, 19 **87**.
