PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 67445 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following 67445 limitations and conditions:

Klamath Hills District Improvement Co. of 280 Main Street, Klamath This permit is issued to Falls, Oregon 97601, phone 882-4436, for the use of the waters of Klamath River, a tributary of Pacific Ocean, for the PURPOSE of irrigation of 597.05 acres and supplemental irrigation of 135.6 acres

that the PRIORITY OF THE RIGHT dates from October 10, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 18.3 Cubic foot per second

The POINT OF DIVERSION is to be LOCATED: South 89 degrees 02 1/4 minutes 8878 feet from the Northeast Corner of Section 1, being within the NE 1/4 NW 1/4 of Section 2, Township 40 South, Range 8 East, WM, in the County of Klamath.

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before May 30, 1985, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1986. Extended to October 1, 1988

Complete application of the water to the proposed use shall be made on or before October 1, 1987 . Extended to October 1, 1989
