PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68050 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Alvin L. McQuigg of HC 86, Box 37, Myrtle Point, Oregon 97458, phone 572-5398, for the use of the waters of North Fork Coquille River, a tributary of Coquille River, for the PURPOSE of irrigation of 11.5 acres, stock use and domestic use for one family, being 0.144 for irrigation, 0.005 cfs for stock and 0.005 cfs for domestic use

that the PRIORITY OF THE RIGHT dates from April 9, 1984

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.154 cfs

The POINT OF DIVERSION is to be LOCATED: 266 feet East and 2090 feet South from the Northwest Corner of Section 1, being within the SW 1/4 NW 1/4 of Section 1, Township 29 South, Range 12 West, WM, in the County of Coos.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 29 South, Range 12 West, WM Section 1 Lot 8 (SW 1/4 NW 1/4) 11.5 acres Irr. and stock
Lot 8 (NW 1/4 NW 1/4) Domestic use and stock

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before May 30, 1985, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 86.

Complete application of the water to the proposed use shall be made on or before October 1, 19 87.
