## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68018** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Thomas H. Ireland, Jr. of 721 Riverside Drive, Myrtle Creek, Oregon 97457, phone 863-3037,** for the use of the waters of Cow Creek,

for the PURPOSE of **irrigation of 15.8 acres**

that the PRIORITY OF THE RIGHT dates from **February 24, 1984**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.2 cubic foot per second**

The POINT OF DIVERSION is to be LOCATED: **11.71 feet North and 8.51 feet East from the Southeast Corner of DLC 44, being within the SE 1/4 NW 1/4 of Section 26, Township 30 South, Range 6 West, WM, in the County of Douglas.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 30 South, Range 6 West, WM Section 26	SW 1/4 NE 1/4	13.3 acres	Irrigation
	NW 1/4 SE 1/4	1.4 acres	
	NE 1/4 SW 1/4	0.1 acre	
	SE 1/4 NW 1/4	1.0 acre	

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/70 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **June 11, 1985**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **86**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **87**
