PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68030** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Sharon Marie Kellogg-Palanuk** of Route 1, Box 213, Agency Creek Road, Grande Ronde, Oregon 97347, phone 879-5661, for the use of the waters of lower spring, when available with any deficiency in the available supply of water from the * for the PURPOSE of stock watering and domestic use for two families including the irrigation of not to exceed one-half acre lawn and noncommercial garden for each family, being 0.01 cfs for stock and 0.01 cfs for domestic use, that the PRIORITY OF THE RIGHT dates from **March 13, 1984**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.02 cubic feet per second**

The POINT OF DIVERSION is to be LOCATED: Lower Spring - 1618 feet South and 1425 feet East from the Northwest Corner of Section 31, being within the SE 1/4 NW 1/4 of Section 31; Upper Spring - 906 feet South and 1546 feet East from the Northwest Corner of Section 31, being within the NE 1/4 NW 1/4 of Section 31, both within Township 5 South, Range 7 West, WM, in the County of Yamhill.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

- * lower spring to be made up by appropriation from the upper spring,

Township 5 South, Range 7 West, WM Section 31 SW 1/4 NW 1/4 Domestic use for two families including the irrigation of not to exceed one-half acre lawn and noncommercial garden stockwater

Actual construction work shall begin on or before **July 13, 1985** and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **86**. Extended to October 1, 1988

Complete application of the water to the proposed use shall be made on or before October 1, 19 **87**. Extended to October 1, 1988
