PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68054 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Garrett Van Diest, Inc., of PO Box 867, Winnemucca, Nevada 89445, phone (702)623-3097, for the use of the waters of Pedee Creek, a tributary of Lukiamute River, and reservoir, to be constructed under Application R-68053, Permit R-9868, for the PURPOSE of irrigation of 35.8 acres

that the PRIORITY OF THE RIGHT dates from April 10, 1984 for 0.062 cfs and June 7, 1984 for 0.388 cfs

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.45 cubic foot per second

The POINT OF DIVERSION is to be LOCATED: Pedee Creek - 200 feet South and 1050 feet East from the N 1/4 Corner of Section 32, being within the NW 1/4 NE 1/4 of Section 32; Reservoir - 10 feet North and 1750 feet East from the Southwest Corner of SE 1/4 of Section 29, being within the SE 1/4 SE 1/4 of Section 29, all in Township 9 South, Range 6 West, WM, in the County of Polk.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 9 South, Range 6 West, WM Section 29 SE 1/4 SE 1/4 3.3 acres SE 1/4 SE 1/4 20.2 acres SW 1/4 SE 1/4 7.3 acres Section 32 NE 1/4 NE 1/4 1.7 acres NW 1/4 NE 1/4 1.5 acres NE 1/4 NE 1/4 1.8 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre from direct flow and storage from reservoir to be constructed under Permit R-9868, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Complete application of the water to the proposed use shall be made on or before October 1, 19 87. Extended to October 1, 1988
