PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68081** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Burnette R. Staffenson of Route 2, Box 840, Alsea, Oregon 97324, phone 487-7204**, for the use of the waters of Alsea River, a tributary of Pacific Ocean,

for the PURPOSE of **irrigation of 5.5 acres and domestic use for one family, being 0.07 cfs for irrigation and 0.005 cfs for domestic use**

that the PRIORITY OF THE RIGHT dates from **May 10, 1984**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.075 cubic foot per second**

The POINT OF DIVERSION is to be LOCATED: **1100 feet South and 1980 feet West from the Northeast Corner of Section 24, being within the NW 1/4 NE 1/4 of Section 24, Township 14 South, Range 9 West, WM, in the County of Benton.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

**Township 14 South, Range 9 West, WM Section 24 NW 1/4 NE 1/4 5.5 acres
Domestic use for one family**

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **July 13, 1985** and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **86**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **87**.
