PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 67548 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Scharf Farms of 9950 Bethel Road, Amity, Oregon 97101, phone 835-6445, for the use of the waters from two reservoirs, being 29.5 acre-feet from Reservoir 1 constructed under Permit R-5319 and 35.8 acre-feet from Reservoir 2 * for the PURPOSE of irrigation of 476.3 acres

that the PRIORITY OF THE RIGHT dates from May 22, 1984

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 65.3 acre-feet stored water only

The POINT OF DIVERSION is to be LOCATED: Diversion 1-560 feet North and 1470 feet East from the Southwest Corner of Section 15, being within the SE 1/4 SW 1/4 of Section 15; Diversion 2-2260 feet North and 640 feet East from the Southwest Corner of Section 15, being within the NW 1/4 SW 1/4 of Section 15; Diversion 3-863 feet North and 640 feet East from the Southwest Corner of Section 15, being within the** A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 2.5 acre-feet per acre from storage from reservoirs constructed under Permits R-5319 and R-6543.

Actual construction work shall begin on or before July 19, 1985, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1986.

Complete application of the water to the proposed use shall be made on or before October 1, 1987 .
