## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68088** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Scharf Farms by John Scharf, Partner of 9950 Bethel Road, Amity, Oregon 97101, phone 835-6445,** for the use of the waters from **Ash Swale, a tributary of Salt Creek, and reservoir constructed under Permits R-2038 and R-8399,** for the PURPOSE of **irrigation of 172.6 acres**

that the PRIORITY OF THE RIGHT dates from **May 22, 1984**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **2.0 cubic feet per second**

The POINT OF DIVERSION is to be LOCATED: **1060 feet South and 750 feet East from the Northwest Corner of Section 19, being within the NW 1/4 NW 1/4 of Section 19, Township 6 South, Range 4 West, WM, in the County of Polk.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre from direct flow and storage from reservoir constructed under Permits R-2038 and R-8399, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **July 19, 1985**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **86**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **87**.
