PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 64061 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Farmers Irrigation District of 1185 Tucker Road, Hood River, Oregon 97031, phone 386-4299, for the use of the waters from Dead Point Creek, South Fork Pine Creek, North Fork Pine Creek, Ditch Creek and Hood River, being 20.0 cubic * for the PURPOSE of development of 4885 theoretical horsepower at Farmers Irrigation District Hydroelectric Generation Plant 2

that the PRIORITY OF THE RIGHT dates from February 11, 1981

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 108 cfs

The POINT OF DIVERSION is to be LOCATED: Dead Point Creek - 330 feet South and 1650 feet East from the Northwest Corner of Section 2, being within the NE 1/4 NW 1/4 of Section 2, Township 1 North, Range 9 East; South Pine Creek - 550 feet North and 1400 feet West from the Southeast Corner of Section 25, being within the SW 1/4 SE 1/4 of Section 25, Township 2 North, Range 9 East; North Pine Creek - 1650 feet North and 1600 feet West **

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

- * feet per second from Dead Point Creek, 5.0 cfs each from North and South Forks of Pine Creek, 20.0 cfs from Ditch Creek, being a maximum of 35.0 cfs from above sources at any one time, and 73.0 cfs from Hood River,
- ** from the Southeast Corner of Section 25, being within the NW 1/4 SE 1/4 of Section 25, Township 2 North, Range 9 East; Ditch Creek - 900 feet South and 300 feet West from the Northeast Corner of Section 24, being within the NE 1/4 NE 1/4 of Section 24, Township 2 North, Range 9 East; Hood River - 2250 feet North and 470 feet East from the Southwest Corner of Section 31, being within the NW 1/4 SW 1/4 of Section 31, Township 2 North, Range 10 East, all in the County of Hood River.

Township 2 North, Range 10 East, WM Section 11 SE 1/4 SE 1/4 Hydroelectric generation

Actual construction work shall begin on or before July 30, 1985, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 86.

Complete application of the water to the proposed use shall be made on or before October 1, 19 87.
