PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68120** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **William J. Doyle** of **4187 Riverbanks Road, Grants Pass, Oregon 97527**, phone **476-0624**, for the use of the waters of **Dutcher Creek** when available with any deficiency in available supply from **Dutcher Creek**, a tributary of **Rogue River**, to* for the PURPOSE of **domestic use for one family**

that the PRIORITY OF THE RIGHT dates from **July 18, 1984**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.005 cubic foot per second**

The POINT OF DIVERSION is to be LOCATED: **Dutcher Creek - 2475 feet North and 740 feet East from the Southwest Corner of Section 14, being within the NW 1/4 SW 1/4 of Section 14; Rogue River - 2840 feet North and 1150 feet East from the Southwest Corner of Section 14, being within the SW 1/4 NW 1/4 of Section 14, Township 36 South, Range 7 West, WM, in the County of Josephine.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

- * be made up by appropriation from **Rogue River**, provided that the total quantity diverted from both sources shall not exceed **0.005 cubic foot per second**,

Township 36 South, Range 7 West, WM Section 14 NW 1/4 SW 1/4 Domestic use for one family

Actual construction work shall begin on or before **July 31, 1985** , and shall thereafter be prosecuted with reasonable diligence and be completed on or before **October 1, 19 86** .

Complete application of the water to the proposed use shall be made on or before **October 1, 19 87** .
