PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 64989 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to U.S. Government - Winema National Forest of PO Box 1390, Klamath Falls, Oregon 97601, phone 882-7761, for the use of the waters of an unnamed stream, a tributary of Sprague River, for the PURPOSE of road construction, maintenance and dust abatement, provided the total

volume diverted shall not exceed 5.0 acre-feet per year

that the PRIORITY OF THE RIGHT dates from April 4, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.0 Cubic per second

The POINT OF DIVERSION is to be LOCATED: 1650 feet North and 530 feet East from the Southwest Corner of Section 35, being within the NW 1/4 SW 1/4 of Section 35, Township 35 South, Range 8 East, WM, in the County of Klamath.
