PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68085** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Bob Meltebeke of 3324 Regent, Eugene, Oregon 97401, phone 686-0024**, for the use of the waters of Daniels Creek and four drainage swales for the purpose of maintaining five reservoirs to be constructed under Application R-68084, * for the PURPOSE of **stockwater and recreation**

that the PRIORITY OF THE RIGHT dates from **May 18, 1984** for the use of **0.1025 cfs** from Daniels Creek for maintaining Reservoirs 1, 2 and 3 for recreation and for maintaining Reservoir 5 for recreation and stockwater; **July 16, 1984** for **0.0225 cfs** from drainage swale 1; **0.0225 cfs** from drainage swale 2; **0.0225 cfs** from drainage swale 3; **0.0425 cfs** from ** and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.22 cfs**

The POINT OF DIVERSION is to be LOCATED: **Reservoir 1 (drainage swale 1) - 400 feet South and 1100 feet East from the Northwest Corner of Section 35, being within the NW 1/4 NW 1/4 of Section 35; Daniels Creek - 2270 feet North and 1200 feet West from the Center 1/4 of Section 35, being within the NE 1/4 NW 1/4 of Section 35; Reservoir 2 - (drainage swale 2) - 720 feet North and 550 feet West from the Center 1/4 of Section 35, being within*****

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

- * **Permit R-9966 for stockwater and recreation,**
- ** **drainage swale 4 for maintaining Reservoirs 1, 2, 3 and 4 for recreation and stockwater; August 16, 1984 for 0.0075 cfs from Daniels Creek for maintaining Reservoirs 1, 2 and 3 for stockwater**
- *** **the SE 1/4 NW 1/4 of Section 35; Daniels Creek - 1180 feet North and 200 feet East from the Center 1/4 of Section 35, being within the SW 1/4 NE 1/4 of Section 35; Reservoir 3 (drainage swale 3) - 1300 feet North and 750 feet East from the Center 1/4 of Section 35, being within the SW 1/4 NE 1/4 of Section 35; Daniels Creek - 800 feet North and 650 feet East from the Center 1/4 of Section 35, being within the SW 1/4 NE 1/4 of Section 35; Reservoir 4 - (drainage swale 4) - 1100 feet South and 560 feet West from the Northeast Corner of Section 35, being within the NE 1/4 NE 1/4 of Section 35; Reservoir 5 - Daniels Creek - 2280 feet South and 500 feet East from the Northwest Corner of Section 36, being within the SW 1/4 NW 1/4 of Section 36, all within the Township 16 South, Range 3 West, WM, in the County of Lane.**

Actual construction work shall begin on or before **August 30, 1985** , and shall thereafter be prosecuted with reasonable diligence and be completed on or before **October 1, 19 86** .

Complete application of the water to the proposed use shall be made on or before **October 1, 19 87** .
