This is to certify that I have examined APPLICATION **58352** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Marvin J. and Marjorie M. Shollenberger of Box 31, Unity, Oregon 97884, phone 446-3470,** for the use of the waters of a spring area, a tributary to **Job Creek,** for the PURPOSE of **supplemental irrigation of 81.5 acres**

that the PRIORITY OF THE RIGHT dates from **February 21, 1979**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **2.04 cubic feet per second**

The POINT OF DIVERSION is to be LOCATED: **240 feet South and 678 feet East from the Northwest Corner of Section 19, being within the NW 1/4 NW 1/4 of Section 19, Township 13 South, Range 37 East, WM, in the County of Baker.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

**Township 13 South, Range 37 East, WM Section 19 NW 1/4 NW 1/4 39.5 acres
NE 1/4 NW 1/4 18.0 acres
SW 1/4 NW 1/4 20.0 acres
SE 1/4 NW 1/4 4.0 acres**

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein,

Actual construction work shall begin on or before **September 27, 1985** and shall thereafter be prosecuted with reasonable diligence and be completed on or before **October 1, 19 86** .

Complete application of the water to the proposed use shall be made on or before **October 1, 19 87** .
