This is to certify that I have examined APPLICATION 64176 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to U.S. Government, Winema National Forest of PO Box 1390, Klamath Falls, Oregon 97601, phone 882-7761, for the use of the waters of Williamson River and an unnamed stream, tributaries of Upper Klamath Lake, provided the total quantity* for the PURPOSE of road construction and maintenance

that the PRIORITY OF THE RIGHT dates from September 27, 1982

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.0 Cubic foot per

The POINT OF DIVERSION is to be LOCATED: Diversion 1 (Williamson River) - 100 feet North and 1350 feet West from the Center Corner of Section 1, being within the SW 1/4 NW 1/4 of Section 1, Township 33 South, Range 7 East, WM,; Diversion 2 (Unnamed Stream) - 860 feet South and 1600 feet West from the Northeast Corner of Section 9, being within the NW 1/4 NE 1/4 of Section 9, Township 32 South, Range 9 East, WM, both in the County** A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:
