PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 64581 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to U.S. Government, Winema National Forest of PO Box 1390, Klamath Falls, Oregon 97601, phone 882-7761, for the use of the waters of Miller Creek, an unnamed stream and Sink Creek, tributaries of Klamath Marsh, provided the total * for the PURPOSE of road construction, maintenance and dust abatement

that the PRIORITY OF THE RIGHT dates from December 16, 1982

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.0 cubic foot per second

The POINT OF DIVERSION is to be LOCATED: Diversion 1 (Miller Creek) - 300 feet North and 2770 feet East from the Southwest Corner of Section 34, being within the SW 1/4 SE 1/4 of Section 34, Township 27 South, Range 7 East, WM; Diversion 2 (Miller Creek) - 3600 feet South and 730 feet West from the Northeast Corner of Section 2, being within the NE 1/4 SE 1/4 of Section 2, Township 28 South, Range 7 East, WM; Diversion 3 (Miller** A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

- * quantity diverted shall not exceed 5.0 acre-feet per year,
- ** Creek) - 220 feet North and 1040 feet West from the Southeast Corner of Section 12, being within the SE 1/4 SE 1/4 of Section 12, Township 28 South, Range 7 East, WM; Diversion 4 (Unnamed Stream) - 1450 feet North and 790 feet East from the Southwest Corner of Section 9, being within the NW 1/4 SW 1/4 of Section 9, Township 28 South, Range 7 East, WM; Diversion 5 (Sink Creek) - 250 feet South and 1580 feet West from the Northeast Corner of Section 19, being within the NW 1/4 NE 1/4 of Section 19, Township 28 South, Range 7 East, WM, all in the County of Klamath.
