PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68206** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Johnnie A. Thomas of Route 3, Box 3626, Hermiston, Oregon 97838, phone 567-3507, for the use of two springs, tributaries of the Columbia River, being 1.42 cubic foot per second from Spring 1 and 1.25 cfs from Spring 2, for the PURPOSE of primary irrigation of 57.0 acres and supplemental irrigation of 50.0 acres**

that the PRIORITY OF THE RIGHT dates from **October 22, 1984 for 2.25 cfs and December 6, 1984 for 0.42 cfs**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **2.67 cfs**

The POINT OF DIVERSION is to be LOCATED: **Spring 1 - 100 feet North and 1840 feet West from the E 1/4 Corner of Section 33, being within the SW 1/4 NE 1/4 of Section 33; Spring 2 - 400 feet South and 1830 feet West from the E 1/4 Corner of Section 33, being within the NW 1/4 SE 1/4 of Section 33, both within Township 5 North, Range 29 East, WM, in the County of Umatilla.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

Actual construction work shall begin on or before **December 21, 1985** and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **86**

Complete application of the water to the proposed use shall be made on or before October 1, 19 **87**
