PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68227** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Jimmy Evans of 17620 Falls City Road, Dallas, Oregon 97338, phone 787-3662**, for the use of the waters of an unnamed intermittent drainageway and Evans Flashboard Reservoir, a tributary of Little Luckiamute River, to be constructed under* for the PURPOSE of **irrigation of 25.0 acres**

that the PRIORITY OF THE RIGHT dates from **November 14, 1984**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.31 cubic foot per second**

The POINT OF DIVERSION is to be LOCATED: **730 feet North and 2400 feet East from the Southwest Corner of Section 23, being within the SE 1/4 SW 1/4 of Section 23, Township 8 South, Range 6 West, WM, in the County of Polk.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 8 South, Range 6 West, WM Section 23 NE 1/4 SW 1/4 6.7 acres
SE 1/4 SW 1/4 13.8 acres
NW 1/4 SE 1/4 2.0 acres
SW 1/4 SE 1/4 2.5 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet from direct flow from storage from reservoir to be constructed under Permit R-10099, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **January 15, 1986** and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **86**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **87**.
