## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68272** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Donald Pond of Route 1, Box 9, Yamhill, Oregon 97148, phone 662-3244,** for the use of the waters of **North Yamhill River, a tributary of Willamette River,** for the PURPOSE of **irrigation of 42.9 acres**

that the PRIORITY OF THE RIGHT dates from **February 7, 1985**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.54 cubic feet per second**

The POINT OF DIVERSION is to be LOCATED: **555 feet South and 1110 feet East from the Northwest Corner of Section 16, being within the NW 1/4 NW 1/4 of Section 16, Township 3 South, Range 4 West, WM, in the County of Yamhill.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **March 12, 1986**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **86**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **87**.
