## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68279** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Robert and Carolyn Otis of Route 1, Box 5617, Sutherlin, Oregon 97479, phone 459-2051,** for the use of the waters of Hinkle Creek, a tributary of Calapooia Creek,  
for the PURPOSE of **irrigation of 4.11 acres**

that the PRIORITY OF THE RIGHT dates from **February 15, 1985**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.05 cubic feet per second**

The POINT OF DIVERSION is to be LOCATED: **1270 feet South and 30 feet West from the N 1/4 Corner of Section 5, being within the SE 1/4 NW 1/4 of Section 5, Township 25 South, Range 3 West, WM, in the County of Douglas.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 25 South, Range 3 West, WM Section 5 Lot 3 (NE 1/4 NW 1/4)	1.80 acres
	Irrigation
SE 1/4 NW 1/4	2.31 acres
	Irrigation

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **April 8, 1986** and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **87**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **88**.
