PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68285** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Dale W. Schultz of PO Box 2384, Northridge, California 91323, phone (818)368-9571,** for the use of the waters of North Umpqua River, a tributary of the Umpqua, for the PURPOSE of **irrigation of 1.2 acres and domestic use for one family**

that the PRIORITY OF THE RIGHT dates from **February 26, 1985**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.02 cubic foot per second, being 0.015 cfs for irrigation and 0.005 cfs for domestic use**

The POINT OF DIVERSION is to be LOCATED: **75 feet South and 15 feet East from the Northwest Corner of the SW 1/4 NW 1/4 of Section 17, being within the SW 1/4 NW 1/4 of Section 17, Township 26 South, Range 4 West, WM, in the County of Douglas.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

**Township 26 South, Range 4 West, WM Section 18 NE 1/4 NE 1/4 0.9 acre
SE 1/4 NE 1/4 0.3 acre and Domestic**

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **April 8, 1986**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **87**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **88**.
