PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 63266 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to City of Portland, a municipal corporation of 1800 SW 6th Avenue, Portland, Oregon 97201, phone 248-5340, for the use of the waters of The Bull Run River, a tributary of Sandy River,

River, a tributary of Sandy River, for the PURPOSE of the development of 9466 theoretical horsepower at the Portland Ground Water Pump Station/Hydropower Generation Project

that the PRIORITY OF THE RIGHT dates from February 16, 1982

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 170.0 cubic foot per second

The POINT OF DIVERSION is to be LOCATED: 760 feet North and 1520 feet West from the Southeast Corner of Section 26, being within the SW 1/4 SE 1/4 of Section 26, Township 1 South, Range 5 East, WM, in the County of Clackamas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 1 North, Range 3 East, WM Sections 19 SW 1/4 NW 1/4 Generation of electrical energy

The right granted herein is expressly made inferior in right and subsequent in time to any appropriation of water from this source which may hereafter be made for domestic, municipal, irrigation or any other beneficial consumptive use, or for storage for such purposes, provided further that the project shall be constructed under the supervision of a registered professional engineer, provided further that the permittee shall comply with the provisions of the order of the water Policy Review Board dated April 4, 1985, and by reference herein made part of this permit, provided further that the permittee must remain qualified as a municipal corporation and that failure to remain qualified or assignment of the permit to a non-municipal corporation will result in cancellation of this permit.

Actual construction work shall begin on or before April 8, 1986 reasonable diligence and be completed on or before October 1, 19 87.
