PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68218 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to M.D. Berg for the Bureau of Land Management of 777 NW Garden Valley Blvd., Roseburg, Oregon 97470, phone 672-4491, for the use of the waters of McNabb Creek and McNabb Creek Reservoir, a tributary of Olalla Creek, to be * for the PURPOSE of maintenance of reservoir for fire control, watering roads, and mixing pesticide, being 0.01 cubic foot per second from McNabb Creek for maintaining McNabb Creek Reservoir for fire control, 1.0 cfs from McNabb Creek and McNabb Creek reservoir** that the PRIORITY OF THE RIGHT dates from October 31, 1984

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.0 cfs

The POINT OF DIVERSION is to be LOCATED: 330 feet South and 110 feet West from the Center 1/4 Corner of Section 11, being within NE 1/4 SW 1/4 of Section 11, Township 29 South, Range 7 West, WM, in the County of Douglas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

- * constructed under Application R-68217, Permit R-10449,
- ** for fire control, 0.7 cfs, not to exceed 98,000 gallons per year from McNabb Creek and McNabb Creek Reservoir for watering roads, and 0.7 cfs not to exceed 3,250 gallons per year, for mixing pesticide.

The right allowed herein shall not authorize appropriation of direct flow water from McNabb Creek during the period from the first day of June through the 30th day of September of each year. Water legally stored may be used at any time.

Actual construction work shall begin on or before April 25, 1986, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1987.

Complete application of the water to the proposed use shall be made on or before October 1, 1988.
