## PERMIT TO APPROPRIATE THE PUBLIC WATERS

68327 This is to certify that I have examined APPLICATION and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

supplemental irrigation of 12.0 acres

April 15, 1985 that the PRIORITY OF THE RIGHT dates from

0.15 cubic foot per and is limited to the amount of water which can be applied to beneficial use and shall not exceed second

The POINT OF DIVERSION is to be LOCATED: 620 feet North and 1190 feet East from the N 1/4 Corner of Section 16, being within the SW 1/4 SE 1/4 of Section 9, Township 33 South, Range 2 East, WM, in the County of Jackson.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 33 South, Range 2 East, WM Section 16 NW 1/4 NE 1/4 12.0 acres Supplemental irrigation

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before May 20, 1986 reasonable diligence and be completed on or before October 1, 19 87.
