PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68264** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **City of Dayville by Mike Ballard, Mayor, City Hall, Dayville, Oregon 97825, phone 987-2941,** for the use of the waters of seven springs, tributaries of Conner Creek, being 0.05 cubic foot per second from each of * for the PURPOSE of **municipal**

that the PRIORITY OF THE RIGHT dates from **January 25, 1985**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.3 cfs**

The POINT OF DIVERSION is to be LOCATED: **Spring 1 - 2460 feet South and 2160 feet West from the E 1/4 Corner of Section 11, being within the SW 1/4 SE 1/4 of Section 11; Spring 2 - 2480 feet South and 2000 feet West from the E 1/4 Corner of Section 11, being within the SW 1/4 SE 1/4 of Section 11; Spring 3 - 1850 feet South and 1560 feet West from the E 1/4 Corner of Section 11, being within the SW 1/4 SE 1/4 of ****

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

- * Springs 1, 2, 5, 6, and 7 and 0.025 cfs from each of Springs 3 and 4
- ** Section 11; Spring 4 - 1780 feet South and 1520 feet West from the E 1/4 Corner of Section 11, being within the SW 1/4 SE 1/4 of Section 11; Spring 5 - 1700 feet South and 1400 feet West from the E 1/4 Corner of Section 11, being within the SW 1/4 SE 1/4 of Section 11; Spring 6 - 2000 feet South and 700 feet West from the E 1/4 Corner of Section 11, being within the SE 1/4 SE 1/4 of Section 11; Spring 7 - 2500 feet South and 750 feet West from the E 1/4 Corner of Section 11, being within the SE 1/4 SE 1/4 of Section 11, all within Township 13 South, Range 26 East, WM, in the County of Grant.
