PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **67985** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Marvin De Raeves of Route 1, Box 303, Amity, Oregon 97101, phone 835-6723**, for the use of the waters of an unnamed reservoir, a tributary of **Ash Swale**, to be constructed under Application R-67984, Permit R-10482, for the PURPOSE of **supplemental irrigation of 154.8 acres**

that the PRIORITY OF THE RIGHT dates from **January 5, 1985**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **103.0 acre-feet stored water only**

The POINT OF DIVERSION is to be LOCATED: **305 feet North and 2700 feet West from the Southeast Corner of Section 7, being within SE 1/4 SW 1/4 of Section 7, Township 6 South, Range 4 West, in the County of Polk.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 2.5 acre-feet per acre from storage from reservoir to be constructed under Permit R-10482, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

Actual construction work shall begin on or before **June 7, 1986**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **87**

Complete application of the water to the proposed use shall be made on or before October 1, 19 **88**
