PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 58324 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Oregon Garden Products, Inc. of 3150 SE Minter Bridge Road, Hillsboro, Oregon 97123, phone 640-4633, for the use of the waters of Davis Creek and Joe Dober Reservoir Enlargement, a tributary of Tualatin River, to be * for the PURPOSE of related nursery uses and supplemental irrigation of 102.0 acres, being 7.85 cubic foot per second from Davis Creek and Joe Dober Reservoir Enlargement for related nursery uses and 0.61 cfs from Davis Creek for supplemental irrigation ** that the PRIORITY OF THE RIGHT dates from April 11, 1985

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 7.85 cfs

The POINT OF DIVERSION is to be LOCATED: 560 feet South and 550 feet East from the Northwest Corner of Section 26, being within the NW 1/4 NW 1/4 of Section 26, Township 1 South, Range 3 West, WM, in the County of Washington.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

- * constructed under Application R-68323, Permit R-10505,
- ** (to bring amount of water up to full duty for irrigation)

Township 1 South, Range 3 West, WM Section 26 NW 1/4 NW 1/4 18.2 acres SW 1/4 NW 1/4 17.8 acres Nursery Use Section 27 NE 1/4 NE 1/4 38.6 acres Nursery Use SE 1/4 NE 1/4 27.4 acres Nursery Use

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet from direct flow and storage from reservoir tobe constructed under Permit R-10505, provided further water shall not be appropriated during the period from July 31 through September 15 of each year except for stored water.

Actual construction work shall begin on or before 341y 2, 1986, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 87

Complete application of the water to the proposed use shall be made on or before October 1, 19 88
