## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 58060 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Hardy Christensen of Route 1, Box 1820, Bandon, Oregon 97411, phone 347-3174, for the use of the waters of Crooked Creek, a tributary of Pacific Ocean.

for the PURPOSE of irrigation of 8.5 acres, temperature control and flood harvesting of cranberries, being 0.21 cubic foot per second for irrigation, 1.28 cfs for temperature control and 0.43 cfs for flood harvesting

that the PRIORITY OF THE RIGHT dates from March 28, 1985

and is limited to the amount of water which can be applied to beneficial use and shall not exceed

1.28 cfs

The POINT OF DIVERSION is to be LOCATED: 130 feet North and 250 feet East from the Northwest Corner of Section 17, being within the SW 1/4 SW 1/4 of Section 8, Township 29 South, Range 14 West, WM, in the County of Coos.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 29 South, Range 14 West, WM Section 17 NW 1/4 NW 1/4 8.5 acres Irrigation temperature control, and flood harvesting of cranberries

If for irrigation, this appropriation shall be limited to 1/40 of one cubic foot per second of its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, for cranberries. If for the irrigation of any other crop, this appropriation shall be limited to 1/80 of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The permittee shall record and submit annually to the Water Resources Department all pertinent data pertaining to use of water for temperature control on forms furnished.

Actual construction work shall begin on or before August 9, 1986, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19

Complete application of the water to the proposed use shall be made on or before October 1, 19
