PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68177 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Steven M. Houston of 86187 Hoya Lane, Eugene, Oregon 97405, phone 747-4681, for the use of the waters of Coast Fork Willamette River, a tributary of Willamette River,

for the PURPOSE of irrigation of 10.0 acres and frost protection on 26.0 acres, being 0.125 cubic foot per second for irrigation and 2.9 cfs for frost protection

that the PRIORITY OF THE RIGHT dates from

September 11, 1984

and is limited to the amount of water which can be applied to beneficial use and shall not exceed

2.9 cfs

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows: Township 18 South, Range 3 West, WM Section 13 SE 1/4 NE 1/4 1.0 ac Township 18 South, Range 2 West, WM Section 18 SW 1/4 NW 1/4 3.0 ac 1.0 acres Irrigation 3.0 acres Irrigation NW 1/4 SW 1/4 6.0 acres Irrigation SW 1/4 NW 1/4 Frost Protection NW 1/4 SW 1/4 Frost Protection Township 18 South, Range 3 West, WM Section 13 SE 1/4 NE 1/4 Frost Protection

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot par second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The permittee shall record and submit annually to the Water Resources Department all pertinent data pertaining to use of water for frost protection on forms furnished.

Actual construction work shall begin on or before August 9, 1986, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 87

Complete application of the water to the proposed use shall be made on or before October 1, 19


