PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68372 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to 38 Sod and Seed Company of 5289 Bluegrass Lane, NE, Silverton, Oregon 97381, phone 581-7823, for the use of the waters of Talbot Slough,

for the PURPOSE of

irrigation of 114.6 acres

that the PRIORITY OF THE RIGHT dates from

June 6, 1985

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.43 cubic foot per second

The POINT OF DIVERSION is to be LOCATED: 13 feet South and 40 feet East from the Southeast Corner of Reason Roby DLC 48, being within the NW 1/4 SE 1/4 of Section 29, Township 9 South, Range 3 West, WM, being within the County of Marion.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 9 South, Range 3 West, WM

Section 29 NW 1/4 NE 1/4 22.9 acres

NE 1/4 NE 1/4 9.4 acres

SW 1/4 NE 1/4 36.6 acres

SE 1/4 NE 1/4 33.6 acres

NW 1/4 SE 1/4 6.8 acres NE 1/4 SE 1/4 5.3 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before August 9, 1986, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 87

Complete application of the water to the proposed use shall be made on or before October 1, 19
