PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68457 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

William Joseph Keller and Carol L. Keller of Route 1, 80x 288-A, This permit is issued to Sheridan, Oregon 97378, phone 843-4417, for the use of the waters of Mill Creek, a tributary of South Yamnill River, for the PURPOSE of irrigation of 5.5 acres

that the PRIORITY OF THE RIGHT dates from

July 30, 1985

and is limited to the amount of water which can be applied to beneficial use and shall not exceed

0.07 cfs

The POINT OF DIVERSION is to be LOCATED: 2090 feet South and 490 feet West from the Northeast Corner of Section 5, being within the SE 1/4 NE 1/4 of Section 5, Township 6 South, Range 6 West, WM, in the County of Yamhill.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 6 South, Range 6 West, WM Section 5 SE 1/4 NE 1/4 0.2 acre

NW 1/4 SE 1/4 0.5 acre NE 1/4 SE 1/4 4.8 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before September 25, 1986nd shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19

Complete application of the water to the proposed use shall be made on or before October 1, 19 88
