## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 63493 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Ila B. Rittenhouse of 4856 Rogue River Hwy., Gold Hill, Oregon 97525, phone 582-0292, for the use of the waters of Rogue River,

for the PURPOSE of irrigation of 0.33 acre

that the PRIORITY OF THE RIGHT dates from August 21, 1985 for 0.004 cfs and September 3, 1985 for 0.006 cfs

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.01 cfs

The POINT OF DIVERSION is to be LOCATED: 50 feet North and 2250 feet East from the Northwest Corner of Section 27, being within the SE 1/4 SW 1/4 of Section 22, Township 36 South, Range 4 West, WM, in the County of Jackson.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 36 South, Range 4 West, WM Section 27 NE 1/4 NW 1/4 0.06 acres  
Section 22 SE 1/4 SW 1/4 0.27 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before September 25, 1986 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 87

Complete application of the water to the proposed use shall be made on or before October 1, 19 88
