PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68404** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Fritz Cutsforth Land Company of Route 2, Box 2225, Heppner, Oregon 97836, phone 989-8485,** for the use of the waters of Milk Canyon, a tributary of Sand Hollow, for the PURPOSE of **supplemental irrigation of 64.9 acres**

that the PRIORITY OF THE RIGHT dates from **June 21, 1985**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.81 cubic foot per second**

The POINT OF DIVERSION is to be LOCATED: **940 feet South and 1790 feet East from the Center Corner of Section 1, being within the NE 1/4 SE 1/4 of Section 1, Township 1 South, Range 26 East, WM, in the County of Morrow.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that although declared herein to be for supplemental irrigation the right allowed may, in the interest of conserving the ground water supplies, be exercised at times when water is available in the ground water supply provided that the total quantity diverted from all sources of supply does not exceed the limitation allowed herein.

Actual construction work shall begin on or before **October 21, 1986** and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **87**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **88**.
