## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 60191 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to United States, Fremont National Forest of PO Box 551, Lakeview, Oregon 97630, phone 947-2151, for the use of the waters of Dairy Creek, a tributary of Chewaucan River, for the PURPOSE of road watering

that the PRIORITY OF THE RIGHT dates from September 26, 1984

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.0 Cubic foot per second

The POINT OF DIVERSION is to be LOCATED: North 26 degrees West 905 feet from the Southeast Corner of Section 31, being within the SE 1/4 SE 1/4 of Section 31, Township 35 South, Range 17 East, WM, in the County of Lake.
