PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68539** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Ronald Walter Thies of Route 1, Box 168, Yamhill, Oregon 97148, phone 662-3380, for the use of the waters of North Yamhill River, a tributary of Yamhill River,**
for the PURPOSE of **irrigation of 52.6 acres**

that the PRIORITY OF THE RIGHT dates from **September 4, 1985 for use of 0.54 cubic foot per second and September 5, 1985 for use of 0.12 cfs**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.66 cfs**

The POINT OF DIVERSION is to be LOCATED: **370 feet North and 1570 feet East from the Southwest Corner of Section 31, being within the SE 1/4 SW 1/4 of Section 31, Township 2 South, Range 4 West, WM, in the County of Yamhill.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **November 1, 1986**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **87**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **88**
