PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68274** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Klicker Bros. of Route 4, Box 236, Walla Walla, Washington 99362, phone (509)525-2494**, for the use of the waters of **Mill Creek, Reynolds House No. 3 Spring and Klicker Mineral Spring**, tributaries of Walla Walla River, for the PURPOSE of **irrigation of 14.0 acres, temperature control and therapeutic uses**, being **0.05 cfs from Mill Creek and 0.13 cfs from Reynolds House 3 Spring for irrigation, 0.54 cfs from Mill Creek and 0.13 cfs from Reynolds House 3 Spring for *** that the PRIORITY OF THE RIGHT dates from **February 8, 1985 for water from Mill Creek and Reynolds House 3 Spring, August 1, 1985 for water from Klicker Mineral Spring**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.672 cfs**

The POINT OF DIVERSION is to be LOCATED: **Mill Creek - South 86 degrees West 1786 feet from the Northeast Corner of Section 19; Reynolds House 3 Spring - South 60 degrees 30 minutes West 2315 feet from the Northeast Corner of Section 19; both being within the NW 1/4 NE 1/4 of Section 19; Klicker Mineral Spring - South 62 degrees 45 minutes East 2035 feet from the Northwest Corner of Section 20, being within the ****

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

- * **temperature control, and 0.002 cfs from Klicker Mineral Spring for therapeutic uses**
- ** **NE 1/4 NW 1/4 of Section 20, all in Township 6 North, Range 38 East, WM, in the County of Umatilla.**

Township 6 North, Range 38 East, WM Section 19 NE 1/4 NE 1/4 4.0 acres
NW 1/4 NE 1/4 10.0 acre
Section 20 NE 1/4 NW 1/4 Mineral baths

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **November 15, 1986** and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **87**

Complete application of the water to the proposed use shall be made on or before October 1, 19 **88**
