PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68325 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Glavis A., Evalee N., and Lorna Reed of Route 2, Box 2618, Rocking R Ranch, La Grande, Oregon 97850, phone 963-8292 or 963-8688, for the use of the waters of Ladd Creek, a tributary of Catherine Creek, for the PURPOSE of irrigation of 9.4 acres

that the PRIORITY OF THE RIGHT dates from April 12, 1985 for 0.13 cfs, August 8, 1985 for 0.11 cfs

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.24 cfs

The POINT OF DIVERSION is to be LOCATED: 1700 feet South and 30 feet West from the Northwest Corner of the SE 1/4 of Section 1, being within the SE 1/4 SW 1/4 of Section 1, Township 4 South, Range 38 East, WM, in the County of Union.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 4 South, Range 38 East, WM Section 1 NW 1/4 SE 1/4 5.2 acres SW 1/4 SE 1/4 4.2 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before November 15, 1986, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 87

Complete application of the water to the proposed use shall be made on or before October 1, 19 88
