PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68495 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Melvin G. Stewart of Box 97, Broadbent, Oregon 97414, phone 572-5795, for the use of the waters of South Fork Coquille River, a tributary of Coquille River, for the PURPOSE of irrigation of 60.0 acres

that the PRIORITY OF THE RIGHT dates from August 22, 1985 for 0.5 cubic foot per second and October 4, 1985 for 0.25 cfs

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.75 cfs

The POINT OF DIVERSION is to be LOCATED: 130 feet South and 1670 feet East from the Northwest Corner of Section 8, being within the NE 1/4 NW 1/4 of Section 8, Township 30 South, Range 12 West, WM, in the County of Coos.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 30 South, Range 12 West, WM Section 8 NW 1/4 NW 1/4 1.0 acre Irrigation SE 1/4 SE 1/4 1.0 acre Section 6 Irrigation Section 8 NE 1/4 NW 1/4 4.0 acres Irrigation Section 5 SW 1/4 SW 1/4 28.0 acres Irrigation SE 1/4 SW 1/4 10.0 acres Irrigation NW 1/4 SW 1/4 3.0 acres Irrigation NE 1/4 SW 1/4 2.0 acres Irrigation Section 7 NE 1/4 NE 1/4 11.0 acres Irrigation

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before November 27, 1986and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19

Complete application of the water to the proposed use shall be made on or before October 1, 19
