## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 68533 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Carl J. Stokes of 1700 Pine Gate Way, White City, Oregon 97503, phone 826-5996, for the use of the waters of the Rogue River, a tributary of Pacific Ocean, for the PURPOSE of irrigation of 24.0 acres

that the PRIORITY OF THE RIGHT dates from August 29, 1985 for 0.18 cubic foot per second and October 18, 1985 for 0.12 cfs

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.3 cfs

The POINT OF DIVERSION is to be LOCATED: 326 feet North and 1720 feet East from the Southwest Corner of Section 29, being within the SE 1/4 SW 1/4 of Section 29, Township 35 South, Range 1 West, WM, in the County of Jackson.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 35 South, Range 1 West, WM Section 29 SW 1/4 SW 1/4 18.8 acres SE 1/4 SW 1/4 5.2 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before November 27, 1986and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 87

Complete application of the water to the proposed use shall be made on or before October 1, 19 88
