PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68583** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Arnold Durazo of 13710 SW Hall Blvd, Tigard, Oregon 97223, phone 620-4338**, for the use of the waters of an unnamed drainage way and Arnold's Reservoir, a tributary of Tualatin River, to be constructed under * for the PURPOSE of **irrigation of 1.5 acres**

that the PRIORITY OF THE RIGHT dates from **October 1, 1985**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.02 cfs**

The POINT OF DIVERSION is to be LOCATED: **55 feet North and 1090 feet East from the Southwest Corner of Section 8, being within the SW 1/4 SW 1/4 of Section 8, Township 2 South, Range 1 West, WM, in the County of Washington.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

* **Application R-68582, Permit R-10588,**

Township 2 South, Range 1 West, WM Section 8 SW 1/4 SW 1/4 1.5 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Provided further water shall not be appropriated during the period from July 31 through September 15 of each year except for stored water.

Actual construction work shall begin on or before **December 16, 1986** and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **87**

Complete application of the water to the proposed use shall be made on or before October 1, 19 **88**
