PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68481** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Grieb Farms, Inc. of Star Route, Box 4170, Lexington, Oregon 97839, phone 989-8585,** for the use of the waters of an unnamed drainageway, a tributary of the Columbia River, for the PURPOSE of **supplemental irrigation of 130.5 acres**

that the PRIORITY OF THE RIGHT dates from **August 9, 1985**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **2.68 cubic feet per second**

The POINT OF DIVERSION is to be LOCATED: **50 feet South and 700 feet East from the W 1/4 Corner of Section 13, being within the NW 1/4 SW 1/4 of Section 13, Township 4 North, Range 25 East, WM, in the County of Morrow.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 4 North, Range 25 East, WM Section 14 SE 1/4 SE 1/4	25.5 acres	Supplemental
Section 13 SW 1/4 SW 1/4	35.0 acres	Irrigation
NW 1/4 SW 1/4	30.0 acres	
Section 14 NE 1/4 SE 1/4	34.9 acres	
SE 1/4 SE 1/4	5.1 acres	

The amount of water used for irrigation together with the amount secured under existing rights for the same lands shall be limited to 1/40 cubic foot per second per acre for each acre irrigated during the irrigation season of each year and shall conform to such reasonable rotation system as may be ordered by proper state officer, provided further that the right allowed herein shall be limited to ny deficiency in the available supply from other sources under prior existing rights for the same land and shall not exceed the limitation allowed herein.

Actual construction work shall begin on or before **March 7, 1987**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **87**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **88**.
