PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **68588** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Larry K. Wright** of 25540 Highway 62, Trail, Oregon 97541, phone **878-2882 (home), 770-4141 (work)**, for the use of the waters of the Rogue River, a tributary of the Pacific Ocean, for the PURPOSE of **irrigation of 0.7 acre**

that the PRIORITY OF THE RIGHT dates from **October 14, 1985**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.01 cfs**

The POINT OF DIVERSION is to be LOCATED: **225 feet South and 610 feet East from the North 1/4 Corner of Section 2, being within the NW 1/4 NE 1/4 of Section 2, Township 34 South, Range 1 West, WM, in the County of Jackson.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 34 South, Range 1 West, WM Section 2 NW 1/4 NE 1/4 0.7 acre

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **March 7, 1987**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **87**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **88**.
